Bulletin of Indonesian Economic Studies

The Bulletin of Indonesian Economic Studies (BIES) Clarivate Impact Factor rose significantly this year to 3.269 from 1.552 in 2021. The Scopus CiteScoreTracker also increased to 4.6 from 3.2 in 2021. The journal also obtained a 1st tier ranking across three research fields: area studies (2/87), economics (129/696) and development (41/287).


