The 35th Indonesia Update conference, *Indonesia in the world: globalisation, nationalism and sovereignty*, was held on 15-16 September. The conference was convened by Mari Pangestu, M Chatib Basri, both from Universitas Indonesia, and Arianto Patunru from ANU. It involved 32 speakers, convenors and session chairs. Approximately 550 people attended the two-day conference.

The conference addressed key issues around globalisation, nationalism and sovereignty in modern Indonesia. Topics included the historical dynamics of Indonesia's engagement with the global world, its stance in the South China Sea and the emergence of new nationalism. Speakers also examined nationalism in practice and the impact of and response to globalisation, as well as poverty, inequality and gender issues.

2017 Mini Indonesia Updates in Adelaide and Sydney

The Mini Update in Adelaide, <u>Indonesia in the new world</u>, was held on 18 September, with M Chatib Basri from Universitas Indonesia, Arief Yusuf from Universitas Padjadjaran and Titik Anas from Presisi Indonesia as speakers. It was chaired by Christopher Findlay from the University of Adelaide.

A conference on political and economic updates in Indonesia was held on the same day at the Lowy Institute in Sydney. This was the twelfth time Lowy Institute held the abbreviated Sydney edition. A full house of about 100 people–including His Excellency David Hurley, Governor of NSW and former Chief of the Australian Defence Force–listened to shortened presentations from the annual Indonesia Update by Mari Pangestu and Raden Pardede (on Indonesian economics) and Thomas Power (on Indonesian politics).

RESEARCH RELATED

The <u>August 2017 issue</u> (53.2) of the *BIES* features Armida S Alisjahbana and Jonah M Busch's Survey of Recent Developments, on forestry, forest fires, and climate change, and M Chatib Basri's Indonesia in ComparativePerspective article, based on his <u>Sadli Lecture</u>, on the lessons that India and Indonesia learned from the 2013 taper tantrum.

The <u>December 2017 issue</u> (53.3; forthcoming) opens with a Survey by Raden Pardede and Shirin Zahro on Indonesia's domestic demand problem. It also includes articles by Vedi R Hadiz, on Indonesia's year of democratic setbacks; Maheshwar Rao and Yogi Vidyattama, on the economic cost of violent conflict in Maluku; Nashrul Wajdi, Sri Moertiningsih Adioetomo, and Clara H Mulder, on interregional migration; and Stephen V Marks, on non-tariff trade regulations.

Now in its fifth year, the *BIES* Economic Dialogue was held in Bandung on 11 December 2017. The paper discussed was titled *Non-tariff trade regulations in Indonesia: nominal and effective rates of protection* by Stephen V Marks from Pomona College, USA, published in the December 2017 issue of *BIES*. Discussions were also held at four other universities in Indonesia: Universitas Sriwijaya in Palembang (12 December), Universitas Mataram (14 December), Universitas Udayana, Denpasar (15 December) and Institut Pertanian Bogor (18 December).

Research Travel Grants

Two Research Travel Grants recipients, Mitchell Morrison from Monash University and Jacob Wray from ANU, presented their research findings during an Indonesia Study Group seminar on 22 November at ANU. Mitchell Morrison presented a topic on the music of talo balak ensemble of Lampung, Sumatra and Jacob Wray presented research on Indonesia and the Japanese occupation based on private memories and national histories.

A new round of applications for Research Travel Grants is now <u>available</u>, with the deadline for submission on 31 March.

Visiting Fellowship

Four Visiting Fellows were hosted from July to December 2017. Budi Aji from Universitas Jenderal Soedirman, Akhmad Rizal Shidiq from Leiden University and Ludia Wambrauw from Universitas Papua visited as part of ANU Indonesia Project Visiting Fellows program. Raden Pardede from CReco Consulting visited ANU Indonesia Project as part of the *Bulletin of Indonesian Economic Studies*' survey of recent developments. He presented the survey findings in the 2017 Indonesia Update, Economic Update session.

OTHER ENGAGEMENTS



A number of meetings were held between ANU Indonesia Project and the Department of Foreign Affairs and Trade (DFAT) in the second semester of 2017. This included a meeting held in conjunction with the Indonesia Update in September, attended by Elcid Li, Anis Hidayah, Shafiah Muhibat and Mari Pangestu, speakers and co-convenor of the 2017 Indonesia Update.

ANU Indonesia Project together with the Australian Treasury and the Indonesian Ministry of Finance organised a pre-High Level Policy Dialogue (HLPD) at ANU on 2 November 2017. Suahasil Nazara, Chairman of BKF, led the Indonesian delegation and Blane Lewis led its ANU counterparts. The dialogue was attended by representatives from DFAT, the Treasury, Indonesian Embassy, ANU academics and PhD students.

Suahasil Nazara presented a public lecture titled *Tax reform to accelerate Indonesian economic growth* at ANU on 2 November 2017. Suahasil Nazara is the Chairman of the Fiscal Policy Agency (BKF) at the Ministry of Finance, Republic of Indonesia. He is also a key economic advisor to the Indonesian Minister of Finance Dr Sri Mulyani Indrawati and a professor at the Faculty of Economics and Business Universitas Indonesia. The event was attended by approximately 70 people. Presentation file and podcast of this event is available.

ANU Indonesia Project <u>participated</u> in the 2017 Indonesia Council Open Conference in Adelaide on 3-4 July. A series of visits to extend our networks and to introduce our programs was also carried out at <u>Gorontalo State University</u>, <u>University of British Columbia</u>, <u>Universitas Udayana and East Nusa Tenggara Province</u>.
