Since December 2019, the coronavirus has swept through all regions of the world. COVID-19 has wreaked havoc everywhere and shows no signs of entirely abating. The Indonesia Project has adjusted its program to focus on COVID-19 related issues. As part of that reorientation, the Project convened a <u>conference</u> in September on the economic dimensions of COVID-19 in Indonesia. This conference replaces the usual Indonesia Update, which has been postponed for one year.

ANU Indonesia Project Global Seminar series with distinguished speakers

A new initiative during the pandemics is the launch of the ANU Indonesia Project Global Seminar series as an urgent response to Covid-19 in Indonesia. The series explores policy challenges, public health measures, and the impact on the economy. We have been honoured to have hosted many distinguished speakers and international experts in these seminars.

The Indonesian Vice-Minister of Finance, Professor Suahasil Nazara, together with Dr Febrio Kacaribu, Head of Badan Kebijakan Fiskal, and Dr Masyita Crystallin, Special Advisor to the Minister of Finance, delivered a seminar on the topic of financing the responses to the Covid-19 pandemic in Indonesia.

Professor Iwan Jaya Azis of Cornell University talked about how this health crisis has transformed into an economic crisis in June. In a conversation with Hal Hill, Professor Azis discussed the unfolding crisis from a global perspective and the impacts in emerging market economies.

The first seminar in this series was delivered by Dr M Chatib Basri from Universitas Indonesia and Indonesia's former Minister of Finance, together with Rizki Siregar from the University of California, Davis. They discussed the health and economic challenges that Indonesian policymakers face in dealing with the pandemic outbreak.

We have also hosted expert panels on gender together with Prospera, rural-livelihoods, jobs and pandemic, regional comparisons, and many other topics.

RESEARCH RELATED

Bulletin of Indonesian Economic Studies

The <u>August 2020 issue (56.2)</u> opened with the Survey of Recent Developments, 'Indonesia in the Time of Covid-19', by Susan Olivia, Rus'an Nasrudin and John Gibson. It examines the impact of Covid-19 on the Indonesian economy, as well as the government's responses to the outbreak. Another Covid-19 article was written by Asep Suryahadi, Ridho Al Izzati and Daniel Suryadarma. It estimates the impact of the outbreak on poverty in Indonesia and describes the implications for the country's social protection programs.

Other articles included an analysis of intragenerational economic mobility, by Teguh Dartanto, Faizal Rahmanto Moeis and Shigeru Otsubo; and a study on the impact of the Batam special economic zone on firm productivity, by Adiwan F. Aritenang and Aryani N. Chandramidi. Book reviews were written by C. Peter Timmer, Jay K. Rosengard and Chris Manning. An obituary on J.B. Sumarlin was contributed by Peter McCawley.

The April 2020 issue (56.1) featured the Survey of Recent Developments by Siwage Dharma Negara and Arief Ramayandi, 'Laying the Foundations for Future Growth Acceleration?' It examines some of the challenges that were facing Jokowi following his inauguration. Other articles included an analysis of religious legislation and discrimination in Indonesia, by Nathanael Sumaktoyo; an investigation of urbanisation and food demand, by Peter Warr; and a study on how to revitalise Batam's economy, by Siwage Dharma Negara and Francis Hutchinson. Book reviews were written by Stephen Marks, Noory Okthariza and Teguh Wicaksono.

Research Travel Grants

Taylah Bell from Murdoch University, Elias Hordern from The University of Sydney, Samira Lindsey from Monash University, and Archana Ramesh from The University of Melbourne are awarded the 2020 Research Travel Grants in principle. Grant disbursements will resume when the travel ban has been lifted and it is safe to travel to Indonesia. Their research topics are on mining development project land rights law, tourism in Bali, bilateral cooperation and Indonesian rule of laws, and spatial urban flow.

For those who have already submitted their application, the application will be considered as soon as the grant process resumes in the future. Donny Pasaribu has graduated in July. Donny's PhD thesis is titled *The Dutch disease, natural resource booms and policy adjustments: the case of Indonesia*, and he was supervised by Hal Hill. Donny was interviewed by SBS Radio Indonesia on the Indonesian economy during the pandemic and on IA-CEPA recently.

GOVERNMENT ENGAGEMENTS

Arianto Patunru provided policy briefings to the Indonesian Minister of Trade on the decrease in Indonesia's Purchasing Managers' Index (PMI), and to the Indonesian Minister of Agriculture in May on food security during the pandemics. He also provided policy briefs on mitigating food supply chain disruption and on Foreign Direct Investment (FDI), published by the Center for Indonesian Policy Studies (CIPS).
